Spijkenisse (7,500 m²)（简称 SP）：拥有危险品运营资质，专门用于锂电池等危险品的储存；

SDAA (32,000 m²)（简称 SD）：同样具备危险品仓储资质，具备大体量、高标准的危险品处理能力。

Feniks 拥有运营危险品仓储的丰富经验。公司总经理 林美（Mei Lin）及多位核心员工持有 PGS 37-2 认证，具备处理锂电池类危险品的专业知识和合规操作能力。

SDAA (32,000 m²) – also hazardous goods certified (SD), a large-scale site capable of handling complex DG warehousing operations.

Feniks has extensive experience operating hazardous goods warehouses. The company's CEO, Meilin Lin, and several core team members hold PGS 37-2 certifications, demonstrating compliance and expertise in dangerous goods handling, especially lithium batteries.
